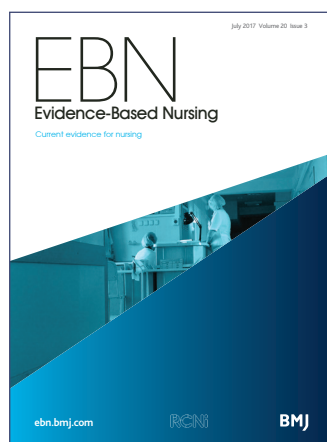

Women's health and midwifery

Child health

- 80 The effectiveness of oral dextrose gel for the treatment of neonatal hypoglycaemia remains unclear
- 81  Parents and informal caregivers feel they receive insufficient communication about routine childhood vaccination


Nursing issues

- 83 Health, psychosocial and workplace characteristics may identify nurses and midwives at risk of high absenteeism
- 84 Nurses require confidence, knowledge and communication skills for referrals to doctors

- 85 Family-centred advanced care planning with adolescents living with HIV is perceived as important, helpful and meaningful
- 86 The effectiveness of protected mealtimes in hospital remains unclear
- 87 Simple variations to traditional models of care can dramatically improve emergency department performance
- 88 Intravenous paracetamol or intravenous propacetamol can provide effective postoperative analgesia for some patients
- 89  Reporting of professional misconduct is influenced by nurses' level of education and managerial experience

Care of the older person

- 91 Assessment and treatment of persistent pain in nursing home residents should be implemented systematically to prevent suffering
- 92 Cognitive-behavioural therapy for insomnia is effective, safe and highly deployable
- 93 Geriatric monitoring units could provide solution to ICU overcrowding and improve survival in older hospitalised patients
- 94 Antidepressant use associated with increased risk of hip fracture in the older population
- 95 The perspectives of patients and their families remain largely unheard in mealtime assistance research
