

#### Nurse education

#### Nursing issues

#### Women's health and midwifery

- 39 Optimising mother–baby outcomes of pregnancy and childbirth in prison requires both individual and systems review
- 40 Midwives experiences are an important factor in identifying and supporting victims of sex trafficking
- 41 Maternal congenital heart disease can have adverse long-term outcomes
- 42 Socioeconomic, ethnic inequalities and adverse pregnancy outcomes: time for the disparities to disappear
- 43 Analysis on the quality and safety of care in relation to neonatal outcomes in alongside midwifery units is reassuring, identifying that specific maternal risk factors have highest predictive value in assessing risk
