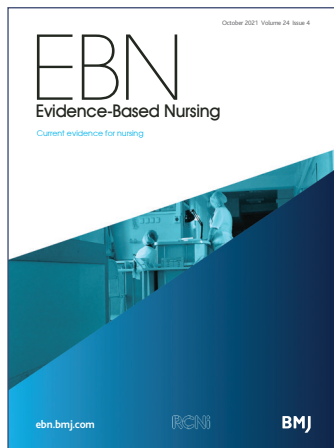

#### Adult nursing

### Health promotion and public health
