

Learning disabilities

- 142 Healthcare professionals who provide palliative care require support to reduce symptoms of burnout

Women's health and midwifery

- 143 Parents' experiences of care offered after stillbirth: available, accessible, acceptable, equitable and effective care
- 144 Non-pharmacological interventions may reduce levels of fear of childbirth, but the reduction may not be clinically significant
