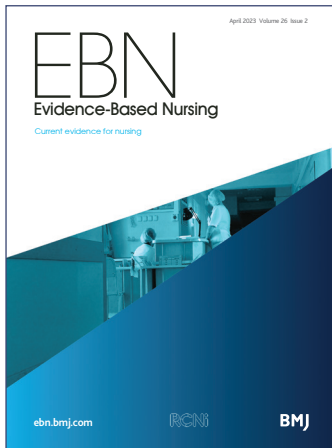

Adult nursing

Palliative care

- 83 Limited knowledge about what matters to older people with multimorbidity hinders appropriate palliative care provision
